O. L. Davis, Jr. Counselor of Distinction Award

At the recommendation of the Kappa Delta Pi Chapter Services Committee, KDP established the O.L. Davis, Jr. Counselor of Distinction Award. The purpose of this award is to acknowledge the service, scholarship, and professional development of chapter counselors. This award also reflects outstanding leadership of the chapter and mentorship of chapter student leaders. There is no limit to the number of recipients in any given year.

REQUIREMENTS: Nomination must be made in a cover Letter of Support from a current or former chapter leader, a colleague or a Kappa Delta Pi Staff Member. During a five-year period, the chapter must show a steady trend of increased member recruitment and/or retention. In addition, the counselor must document, in an electronic or paper portfolio, a minimum of five examples in each category: service, scholarship, and professional development within the five-year period. Individual criteria may be used only twice. (For example, if you presented a workshop at two different Convocations, this would count as two different items.) The total value of examples submitted must equal or exceed 100 points. Annual Reports must have been submitted by the deadline each year of the five-year period of consideration.

Dr. O. L. Davis, Jr. served as the Chapter Counselor of the Delta Chapter of Kappa Delta Pi at the University of Texas at Austin for more than 40 years. His example and mentorship led many of his former students to become KDP counselors and Society leaders. In addition, he was Kappa Delta Pi Society President for the 1980–82 biennium. In 1994, he was named to the distinguished Laureate Chapter of the Society. He also has served Kappa Delta Pi as a scholarship reviewer and has published several articles with KDP. Dr. Davis and his students established a Laureate Doctoral Scholarship that is named in his honor through the Kappa Delta Pi Educational Foundation.
